Bay of Green Bay National Estuarine Research Reserve (NERR)

Talking points

- The University of Wisconsin-Green Bay is leading the designation process
- Non-regulatory and state-owned/managed
- State-NOAA partnership for research, education, and training
 - o The state is responsible for the day-to-day management of the reserve
 - NOAA administers the entire reserve system; responsible for establishing standards for designation and operating reserves that benefit the entire system
- Green Bay NERR representing the Lake Michigan/Huron Basin
 - o Physical location in waters of Green Bay
 - o Programs and resources for the region
- Joining a national network (29 reserves, 1.3 million acres) to tell the story of Green Bay
 - o World's largest freshwater estuary
 - Highlight cultural and economic connections to water
- 'Locally Relevant, Nationally Significant' = address local coastal management issues (changing water levels, PFAS, harmful algae blooms, etc.) while elevating the national and international visibility of Green Bay
- ~\$1 million/year for water-focused Research, Education, Stewardship, Training (REST)
 - o At least one staff position for each area of REST
- A visitor center for hands-on and place-based education, lab space, conference area, dorms, boats
- Goals for a Green Bay NERR:
 - o To be the most "technologically advanced" NERR in the system
 - o Think holistically about all the ways water touches our lives

Activities of a NERR- Research, Education, Stewardship, Training (REST)

- 1) Research Data contributes to national network assessing the health of estuaries; Davidson Graduate Research Fellowship Program 2-year, NOAA sponsored.
- 2) Education Work with K-12 school districts; Teacher on the Estuary Program- train teachers in coastal and estuary science.
- 3) Stewardship Mapping; restoration; interdisciplinary problem-solving.
- 4) Training Technical assistance on coastal zone challenges (stormwater management, coastal development, working waterfronts): Bring science to local decision-making: Access to national NOAA expertise in coastal economics, policy, modeling, science communication.





Timeline of Designation

6 steps to complete - 4-6 years total - goal of designation by end of 2024

- ✓ Letter of Interest from Governor completed Summer 2019
- Site selection & Nomination* started November 2020
- Draft Environmental Impact Statement (NOAA lead) and Management Plan for the Reserve (UWGB lead).
 - o Management activities reflect local interest in the site and include activities already happening in the area –fishing, birding, hunting, etc.
- Public review and finalize EIS and Management Plan
- Designation findings and certificate; Record of Decision
- Designation Ceremony

*Site Selection & Nomination - goal of site selection complete by Fall 2022

- 1. Determine Committees Site Coordination; Site Development; Site Evaluation
- 2. Develop pre-screening criteria
- 3. Identify 3-5 potential representative sites
- 4. Public meetings to seek stakeholder views
- 5. Final site selected
- 6. Delineate site boundaries
- 7. Nomination Document submitted to Governor's office and then NOAA

Each NERR site provides a "living laboratory" in which scientists and educators conduct research, outreach, and education regarding our estuarine-based natural resources. Each NERR site enhances place-based research, creates distinct educational resources, facilitates local stewardship of aquatic natural resources, and supports local economic development.

What are the benefits of a NERR for Northeastern Wisconsin?

Regional Impact


Established reserves have exemplary visitor centers, providing international exposure and significant drawing power for tourists. NERR centers draw significant research dollars, improving our understanding of the globally unique Green Bay Ecosystem. Research activities draw scholars, and their funding, from beyond Wisconsin and US borders, they provide employment opportunities to the region, and enhance the quality of UW-Green Bay's scholarly activities, ultimately injecting money into the local economy.

Tourism

A NERR site will enhance the already robust tourism industry in the Green Bay/ Door County region. Formal designation generates international visibility for the Green Bay Ecosystem and the communities it supports.

Education

The center will provide a centralized location for educational opportunities and will be a draw for families, young talent, retirees, and other visitors alike. It will be an exemplary resource for educators addressing students of all ages, from pre-K to retired learners. Imagine a well-funded center filled with aquariums stocked with Great Lakes fish, interactive stations addressing maritime topics from shipping to drinking water conservation, and regularly scheduled tours leaving for the waters of Green Bay.

Workforce Development & Quality of Life

Through efforts towards research, education, stewardship, and training NERR designation will play an important role in attaining Northeastern Wisconsin's goal to attract and retain young talent.

A NERR System supports local economic development, enhances place-based research, creates distinct education based resources, and facilitates local stewardship of aquatic natural resources.

How do freshwater estuaries enhance quality of life in the Green Bay Ecosystem?

Freshwater estuaries occur in the Great Lakes where rivers meet the lake. The freshwater estuaries within the Green Bay Ecosystem provide critical habitat for wildlife, improve water quality, create recreational opportunities for sportsmen and outdoor enthusiasts, and give our communities a strong sense of place.

Does a NERR restrict existing commercial, recreational, or cultural activities?

NERR designation does not preclude any uses, activities, or impose limits on development. No new federal regulations affecting land management or public access are required, and NERR regulations are agreed upon by the local community during the development of the reserve management plan. There are no regulations for shipping vessels, lakers, or ports. A NERR is not a sanctuary or refuge.

Will the public have to purchase new land for the reserve?

A local working group will work with NOAA to identify existing publicly owned land to house the Green Bay Ecosystem NERR. No increase in local public taxes or funding is required for a NERR. Final site selection is a collaborative process among interested local partners and citizens.
