### PURPOSE:

Request that the Cemetery Board increase fees per our discussion at March 2020 meeting.

### **BACKGROUND:**

The cost of foundations has increased by \$10.00 each so the price needs to be increased in order to cover the increased cost (foundation increase approved at January 10, 2020 meeting). In addition, we are not charging extra for winter vault burials (only winter cremations) even though there is a much larger area to thaw. The City of Menominee is losing \$300.11 on every winter vault burial and \$64.78 on every winter cremation burial. Instead of adding a winter vault burial fee, it was recommended by the Cemetery Board to increase all fees. The increases in burial fees were discussed at last meeting and are attached.

### SUMMARY:

This increase in fees will increase the revenue generated by the cemetery in order to cover the increase in foundation costs, the increase in labor costs and the fuel to heat the ground during winter burials.

BUDGET IMPACT: This increase in fees will increase the revenue generated by the cemetery.

### STAFF RECOMMENDATION / ACTION REQUESTED:

The Director of DPW recommends that the Cemetery Board raises the foundation/flush marker price \$0.05 per square inch to\$0.40 per square inch (foundation increase approved at January 10, 2020 meeting). In addition, the burial fees should be increased per the attached draft fee schedule.

To recommend to City Council that Council approve the fee adjustments dated May 5, 2020 effective July 1, 2020.
